## Classy 100 and The For Women Only Expo Cupcake Contest CONTEST OFFICIAL RULES

Classy 100 will select 15 contestants from all of the entries. Those 15 contestants will participate in the qualifying round for their chance to be one of 5 finalists in the Ultimate Cupcake Contest Finals. All entries must be received by 5pm EST on October 6, 2017. Each weekday morning from October 16, 2017 through October 20, 2017 three (3) of the 15 qualifiers will have their cupcake recipe sampled by Classy-100 judges. The top five entries with the top five highest scores out of the 15 finalists, will compete on Saturday October 28, 2017 at 3 p.m. at the For Women Only Expo located at the Bayfront Convention Center. All five finalist's cupcake recipes will be judged on October 28, 2017 at the For Women Only expo by a group of chefs supplied by Erie Promotions and one finalist will be named the winner of the Ultimate Cupcake Contest.

Four (4) finalists will each receive (1) Qualifying Prize of BREAD FOR A YEAR FROM PANERA worth over \$300.

Fifteen (15) family 4 packs of tickets to the For Women Only Expo for 15 qualifiers, valued at \$20 per four pack.

. **Limit one (1) entry per person.** Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification.

Station's decisions as to the administration and operation of the Contest and the selection of the potential winner is final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.

3. Verification of Potential Winner. POTENTIAL CONTEST WINNER IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner will be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a sweepstakes prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. A winner who accepts a prize cannot rescind their acceptance and/or return the prize.

**4. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
