- Contest Period. The Contest will begin at 8:00a.m. ET on May 29, 2018 and will run through 5 p.m.. ET on June 18, 2018 (the õContest Periodö). The Stationøs computer is the official time keeping device for this Contest.

(i) <u>On-Air</u>: Listen to the Station beginning Monday May 29, 2018 through Friday June 18, 2018 between 8am and 5p.m. When the Station plays the õcue-to-callö sounder, listeners should call the Station at 814-868-9100. Caller ten (10) to the Station, as determined by the Station in its sole discretion, will qualify to win. <u>Time Delay Between Over-the-Air Analog Signal and Internet</u> <u>Broadcast</u>: Due to the time delay that exists between the Stationøs analog over-the-air signal and the Stationøs online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Stationøs analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

- 4. **Winner Selection.** On Friday June 18, 2018, station will select one random winner from all qualifiers. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules).
