The Station will conduct the Classy 100 **THE BREWERIE AT UNION STATION SWEET DEAL CERTIFICATE GIVEAWAY** (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 2. **Contest Period.** The Contest will begin at 3:00pm ET on Thursday April 11, 2018 and will run through 9am ET on April 12, 2018 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** To enter:
 - On-Air: Listen to the Station on Thursday April 11, 2018 in the afternoon between 3 p.m. and 5 p.m. and Friday April 12, 2018 in the morning between 7 a.m. and 9 a.m. during the Breakfast Club. When the Station plays the "cue-to-call" sounder, listeners should call the Station at 814-868-9100. Caller ten (10) to the Station, as determined by the Station in its sole discretion, will win. Time Delay between Over-the-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished..
- 4. **Winner Selection.** The tenth (10th) caller, as described above, may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Caller will be notified at the time of his/her call. Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest
