

## CLASSY 100 MORNING MINDBENDER LIVE ON MARS MARCH TICKET GIVEAWAY CONTEST OFFICIAL RULES

The Station will conduct the CLASSY 100 MORNING MIND BENDER LIVE ON MARS March Ticket Giveaway Contest (the öContestö) substantially as described in these rules, and by participating, each participant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

The term öhousehold membersö refers to people who share the same residence at least three (3) months out of the year. 2. **Contest Period.** The Contest will begin at **6:am ET on May 1, 2019** and will run through **9AM ET on May 17, 2019** (the öContest Periodö). The Station's computer is the official time keeping device for this Contest.

3. **How to Enter.** To enter:

**On-Air:** Listen to the Station May 1, 2019 through May 17, 2019 between 6:00am and 9:00am. When the DJ gives the morning mindbender questionl, listeners should call the Station at 814-868-9100 with the correct answer. Caller 10 (10) with the correct answer to the Station, as determined by the Station in its sole discretion, will win. ***Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:*** Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

4. **Winner Selection.** The tenth (10<sup>th</sup>) caller with correct answer as described above, may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Caller will be notified at the time of his/her call. Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest
5. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
