## CLASSY 100'S SUPERSTORE HIGH LOW CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WXKC (õClassy 100 FMö), owned and operated by Cumulus Radio LLC located at 471 Robison Road Erie PA 16509, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the CLASSY 100¢ Superstore High Low Contest substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents, age eighteen (18) years or older, or at the time of entry with a valid Social Security number and who reside in the Station Designated Market Area (õDMAÖ) as defined by Nielsen Audio, who have not won a prize from the Station in the last thirty days or a prize valued at \$500 or more in the last sixty days, and whose immediate family members or household members have not won a prize from the Station in the last thirty days or a prize valued at \$500 or more in the last sixty days. Void where prohibited by law. The term õimmediate family membersö includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term õhousehold membersö refers to people who share the same residence at least three (3) months out of the year. - 2. **Contest Period.** The Contest will begin on Monday, July 8, 2019 at 8:15am and end on Friday, August 2, 2019 at 9:00 a.m. The Stationøs computer is the official time keeping device for this Contest.
- 3. **How to Enter.** To enter:

Beginning on July 8, 2019 through August 2, 2019 listeners should watch WICU 12 NEWS at 12:30p.m, 5:30p.m. and/or 11:00 p.m. for the Auto Express Resale Center Superstore High Low winning price; they must also listen to Classy 100 weekdays Monday through Friday at 8:15am during the Contest Period. When the Station plays the õcue-to-callö sounder, listeners should call the Station at (814)868-9100. Caller ten (10) with the winning Auto Express Resale Center Superstore High Low price to the Station, as determined by the Station in its sole discretion, will win. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station analog over-the-air signal and the Station online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station analog over-the-air signal. As a result, the odds of an online listener winning this Contest may be diminished.

- 4. **Winner Selection.** The tenth (10<sup>th</sup>) caller with the winning Superstore High Low price, as described above, may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Caller will be notified at the time of his/her call. Station@ decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest
- 5. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
