## CLASSY 100 Cookie Contest at Her, a weekend for the she tribe OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WXKC (õClassy 100ö) owned and operated by Cumulus Radio LLC located at 471 Robison Road Erie PA 16509, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the CLASSY 100 Cookie Contest at Her, a weekend for the she tribe substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

**Eligibility.** This Contest is open only to legal U.S. residents, age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in the Station Designated Market Area (õDMAö) as defined by Nielsen Audio, who have not won a prize from the Station in the last **thirty days** or a prize valued at \$500 or more in the **Erie PA Market**, and whose immediate family members or household members have not won a prize from the Station in the last **thirty days** or a prize valued at \$500 or more in the **Erie PA Market**, and whose immediate family members or household members have not won a prize from the Station in the last **thirty days** or a prize valued at \$500 or more in the **Erie PA Market**. **Void where prohibited by law**. Employees of Cumulus Radio LLC , its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term õimmediate family membersö includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term õhousehold membersö refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrantøs full and unconditional agreement to these Official Rules and Stationøs decisions, which are final and binding in all matters related to the Contest. - 2. Contest Period. The Contest will begin at 6am ET on October 9, 2019 and will run through 12pm ET on November 16, 2019 (the õContest Periodö). The Stationøs computer is the official time keeping device for this Contest.
- 3. **How to Enter.** To enter:

On-Air: Beginning 6am on Wednesday, October 9, 2019 through 5pm Friday, October 25, 2019 station will accept submissions for the Cookie Contest. Listeners can email a valid entry form, along with their cookie recipe made from scratch and a picture of the cookie to the station at contest@classy100.com or they can drop off, or mail it to Classy 100 471 Robison road, Erie PA 16509. All valid entries must be received by Friday October 25, 2019 by 5 p.m. Classy 100 judges will select up to 15 qualifiers from the valid entries and those gualifiers will compete in the gualifying round to be one of 5 finalists in the Cookie Contest at Her, a weekend for the she tribe at the Bayfront convention Center. The qualifying round consists of up to 3 contestants, each weekday morning, from November 4, 2019 through November 8, 2019. At 6:15 a.m. each gualifier will bake and display at least one dozen cookies (one dozen minimum) from the original recipe that they submitted into the contest. Qualifiers must be at the station, at 471 Robison Road, Erie, PA 16509 by 6:15 a.m. during their designated day. Each weekday, a panel of judges will sample and score the cupcakes on a scale of 1 to 5 for Decoration/Presentation and Overall Creativity, 5 being the highest possible score for each category. And, they will also be scored on Flavor/Taste on a scale of 1 to 10 with 10 being the highest possible score for that category. The top 5 contestants with the highest combined scores will compete at the Cupcake Finals on Saturday November 16, 2019 at 12pm at the Her, a weekend for the she tribe show located at the Bayfront Convention Center. The five finalists must be at the Bayfront Convention Center by 11 a.m. on Saturday, November 16, 2019 and must bake and display another dozen cookies (one dozen minimum) from the original

recipe that they submitted. The five finalisto cookie recipes will be judged on November 16, 2019 by a group of judges supplied by Erie Promotions. One finalist will be named the winner of the Cookie Contest.

<u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Stationøs analog over-the-air signal and the Stationøs online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Stationøs analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

**Winner Selection.** Five finalists will compete on Saturday November 16, 2019 at 12pm at the Her, a weekend for the she tribe show located at the Bayfront Convention Center. All five finalists cookie recipes will be judged on November 16, 2019 by a group of judges supplied by Erie Promotions and one finalist will be named the winner of the Cookie Contest.

- 4. (subject to verification of eligibility and compliance with the terms of these rules). Caller will be notified at the time of his/her call. Stationøs decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest
- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
