WXKC-FM'S "STEVIE NICKS MOVIE" CONTEST OFFICIAL RULES

The Station will conduct the WXKC-FM **"Stevie Nicks Movie"** Contest (the õContestö) substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents, excluding dual Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in the Stationøs Designated Market Area (õDMAö) as defined by Nielsen Audio, who have not won a prize from the Station in the last 60 days or a prize valued at \$500 or more. - 2. Contest Period. The Contest will begin at 12:00am ET on 10/08/2020 and will run through 8:59am ET on 10/14/2020 (the õContest Periodö). The Stationøs computer is the official time keeping device for this Contest.
- 3. **How to Enter.** To enter:

Visit the Stationøs website <u>www.Classy100.com</u> during the Contest Period, click on the õContestö link, click on the õStevie Nicksö Contest link, and complete an entry form. All entries must be received by 9:15am ET on October 14, 2020. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The õauthorized account holderö is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.

On or about 9:00am ET on 10/14/2020, Station will select five (5) winners in a random drawing from among all valid entries received by Station during the Contest Period. The winners will be contacted using the email address and/or telephone number provided with the entry and may be awarded a prize (subject to verification of eligibility and compliance with the terms of these rules). Stationøs decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize. **LIMIT ONE PRIZE PER PERSON.**

The approximate retail value (õARVö) of each prize is Thirty Dollars (\$30)

TOTAL ARV OF ALL PRIZES IS: ONE HUNDRED FIFTY DOLLARS (\$150).

Station¢s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
