## WXKC-FM © õPAY IT FORWARD Ö CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WXKC-FM, 471 Robison Road, Erie, PA 16509 during available business hours, on the Station website at www.class100.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WXKC-FM Pay It Forward Contest (the õContestö) substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries must be received by 6:00am ET on November 20, 2020. Limit one (1) entry per household. Multiple entrants are not permitted to share the same email address.
