WXKC-FM'S "SHARE THE LOVE – LIVE VIRTUALLY!" CONTEST OFFICIAL RULES

The Station will conduct the WXKC-FM õSHARE THE LOVE ó LIVE VIRTUALLY!Ö Contest (the õContestö) substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Prize Winnerö) in a random drawing from among the ten Finalists, who will win the grand prize (the õGrand Prizeö).. Each Finalist will be contacted using the email address and/or telephone number provided by the entry and may be awarded a prize (subject to verification of eligibility and compliance with the terms of these rules). Stationøs decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest.
