Contest Rules

The Station will conduct the Classy 100 "Erie Philharmonic Come Home for the Holidays ticket giveaway" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. Vom WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 Days or a prize valuedat \$500 or more in the last in the last 6 months, and whose immediate family members or household members have not won a prize from the Station in the last 30 Days or a prize valued at \$500 or more in the in the last 6 months. - 2. Contest Period. The Contest entry period will begin at 6:00am. EDT on November 24, 2021 and will run weekdays from until 10 am. EDT thru November 30, 2021 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter.

On-Air: Listen to the Station weekdays during the Contest Period from 6am-10am and when you hear the "cue-to-call" sounder, listeners must call the Station at 814-868-9100. The first caller to the Station, as determined by the Station in its sole discretion, will win. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

4. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATIERS RELATED TO THE CONTEST.
