CLASSY 100'S "TAYLOR PLUS ED IS 4" CONTEST OFFICIAL RULES

Eligibility. All entries must be received during the contest period and before 6pm ET on April 21, 2023, to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest.
