CLASSY 100'S "TEXT TO WIN WEEKEND PAW PATROL" CONTEST OFFICIAL RULES

Eligibility. - 3. How to Enter. <u>Text</u>: During the Contest Period, listeners will be able to text the announced keyword "PAWS" spelled correctly to the Station at 814-868-9100 during the Contest Period. All entries must be received by 11:59pm ET on Sunday, April 7th, 2024, to be eligible for a chance to win the grand prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.
- 4. **Winner Selection.** At or about 12:00pm ET on Monday, April 8th, 2024, Station will select 1 potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each phone number will only be counted once in a given day. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
